## Program Information

### Monday, November 23, 2015

Over the years, evaluation, despite its acknowledged importance to teaching and learning, has not consistently taken place in schools and districts. This past school year (2014-15), all schools and districts were required to submit, in the Adaptive System of School Improvement Support Tools (ASSIST), an educational evaluation of a program, initiative or planned strategy using the Michigan Evaluation Tool. (This activity turned into a compliance task for many schools/districts.) What seemed to be missing, from this state required activity, and possibly a strong reason why evaluation has been inconsistent, in the past, was an evaluation mindset that drives systems to grow and improve as learning organizations.

Mindsets are self-beliefs people, and organizations, hold about themselves and others. They tend to determine behaviors, outlooks and mental attitudes. People can have a growth mindset (belief that success can come from hard work and tenacity) or a fixed mindset (belief that ability is pre-determined and innate). Which of the two mindsets is beneficial for an evaluator to hold?

The nature of evaluation (to judge the worth or merit of something) may trigger a performance orientation in the evaluator, as well as, those being evaluated which could interfere with deep change occurring. Holding a growth mindset will help the evaluation process initiate deep thinking about outcomes.



Dr. Diane Jackson will provide an informative, engaging and thoughtful day for those interested in expanding their evaluation mindsets. Dr. Jackson is an accomplished cognitive and leadership coach, as well as a published author. She has over 40 years of educational experience as an administrator, supervisor, coordinator, staff

developer, adult facilitator, coach and teacher primarily with the Detroit Public Schools (DPS). In addition to her DPS work, she has also taught at Wayne State University as an adjunct professor. Finally, Dr. Jackson spent nine years as a national trainer and education consultant for the Efficacy Institute in Lexington, Massachusetts.

#### Tuesday, November 24, 2015

Day two of the conference will offer updates and perspectives, from Michigan educational leaders, on critical Michigan topics. Day one participants will be able to take what they learned about growth mindsets and, based on the information they hear on day two, begin to take a growth mindset approach on appealing topics that could start a change process for improvement at one's respective school, district or organization.
